

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://LivingStonesCenter.org> and Living Stones Church, Inc. (alias Living Stones Center) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Living Stones Center include <https://LivingStonesCenter.org> and LSC. By using the LSC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, LSC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase LSCs products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

LSC may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

LSC collects and uses your personal information to operate its website(s) and deliver the services you have requested.

LSC may also use your personally identifiable information to inform you of other products or services available from LSC and its affiliates.

Sharing Information with Third Parties

LSC does not sell, rent or lease its customer lists to third parties.

LSC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to LSC, and they are required to maintain the confidentiality of your information.

LSC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on LSC or the site; (b) protect and defend the rights or property of LSC; and/or (c) act under exigent circumstances to protect the personal safety of users of LSC, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by LSC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the LSC website.

Use of Cookies

The LSC website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
